

### Exterior use

Suitable for travertine, limestone, sandstone, slate, marble, porcelain, granite, terracotta, quarry tiles, brick & all patio paving.

Effective for removing grease and ingrained dirt and grime.

**Important:** Mask and protect painted surfaces, untreated wood and other sensitive areas. Any alkalinity/product remaining on surfaces should be rinsed off. This may be done with a little clean water applied by sponge.

### Directions for use

#### SHAKE WELL BEFORE USE

Always test on an inconspicuous area before general application.

**Mild cases:** Dilute 1:10 parts in warm water. Apply with a light pressure sprayer or scrubbing brush. Agitate the surface using a deck brush or scrubbing brush. Rinse by hosing off thoroughly with clean water.

**Severe cases:** Dilute 1:3 parts warm water. Apply liberally using a light pressure sprayer or spreading over the surface with a deck brush. Leave for 5-10 minutes and then agitate the surface using a deck brush or scrubbing brush. Rinse by hosing off thoroughly with clean water.

**Extreme cases:** Apply undiluted, add a little water and agitate with a deck brush or scrubbing brush. Leave for 10 - 15 minutes and then agitate the surface using a deck brush or scrubbing brush. Rinse by hosing off thoroughly with clean water.

**NB.** In all cases on larger areas mechanical scrubbers can also be used. Do not use when surface temperatures are under 5°C or over 25°C.

### Storage information

**KEEP UPRIGHT** in a cool, dry, frost free environment.

**Shelf life:** to 2 years for unopened containers.

Once opened use within 6 months of purchase for optimum results.

Empty containers are recyclable. Active ingredients are water soluble and inert once cured so therefore not harmful to the environment and ecologically sound.

### Coverage Per Litre

Mild cases - approximately 50m<sup>2</sup>

Severe cases - approximately 20m<sup>2</sup>

Extremely severe cases - approximately 5-10m<sup>2</sup>

### Notes

Cleaned patios that have been previously sealed should be re-sealed after using this product. This should be done after rinsing with plenty of clean water and once surfaces have had sufficient time to thoroughly dry (min. 24hrs).

### Health, Safety & Environmental
